
^{**} The offense "Disruption of Transportation" refers to when an individual intentionally interferes with the transportation of children to or from school (or a school-related activity). This section of the Texas Education Code was repealed in 2013 following the passage of Senate Bill 393.




Number of Students Charged with "Disorderly Conduct" by Student Race and Academic Year




Note. The chart above shows the number of McKinney ISD students charged with "Disorderly Conduct" before SB 393 passed (2012-13), immediately after the law change (2013-14), and approximately one year later (2014-15). The increasing disparity between White and Black students is most apparent when viewed by academic year.
